# Teakle Auto Sprint Port Lincoln 11th & 12th April 2020

## WELCOME

Welcome to the 3<sup>rd</sup> Teakle Auto Sprint Port Lincoln.

We wish to build on the great success of the first two events, but we will be keeping the relaxed and friendly atmosphere in our pit area with the great public access, however we will also be promoting that winning on the track is a serious and sort after prize.

The main change to the event for 2020 is using the longer 1500m course on both Saturday and Sunday. As fellow drivers we think it will be great to be on the same track both days, something to get your teeth into. Accumulated times over the two days is still in place encouraging fast times all weekend, great for the spectators.

There has been a change to the hairpin prior to the finish line due to some new kerbing. The distance from turn 8 to the hairpin has been shortened by approx. 22m, resulting in crossing the finish line right at the exit of the hairpin (turn 9). This change allows us to keep the width of the hairpin the same as previous events. The remainder of the layout is the same as the previous event.

One of the unique elements of the Teakle Auto Sprint is the wide variety of cars that compete. Whether its circuit or hill climb or dirt and tarmac rally cars we encourage your entry. We also have limited space for non-logbook cars. The variety is great for the hard-fought competition and a wonderful experience for spectators.

As was the case in 2018 the pit/paddock area for all competing cars will be on the foreshore lawns.

We are grateful for the continued support of all our sponsors and partners. However, special thanks must go to Peter Teakle for his generous support by being our naming rights sponsor.

Thanks also go to the Port Lincoln City Council and to all those residents and businesses around the track. Please be courteous and friendly and support those businesses if you are able when in Port Lincoln for the event.

## 1 EVENT SUMMARY

### Article 1.1 - EVENT SUMMARY

#### **THESE REGULATIONS ARE TO BE READ IN CONJUNCTION WITH THE CURRENT CAMS MANUAL OF MOTOR SPORT AND ANY FURTHER REGULATIONS, BULLETINS OR INSTRUCTIONS ISSUED BY THE ORGANISERS.**

- 1.1.1 The event will be held under the International Sporting Code of the FIA, the National Competition Rules of CAMS, the Speed Event Standing Regulations, the CAMS Passenger in Vehicle Guidelines, these Supplementary Regulations, Further Regulations and any Bulletins or Instructions to competitors that may be issued.
- 1.1.2 Where there is any divergence between the current CAMS Manual of Motor Sport and these Event Supplementary Regulations, the current CAMS Manual of Motor Sport will take precedence.
- 1.1.3 The 2020 Teakle Auto Sprint, hereinafter referred to as 'the event'
- Will use electronic timing to 0.01 second.
  - Is approved to run by CAMS.
  - The event will be a multi-club, speed event comprising of timed sprints conducted on two courses, held on sealed (bitumen) closed public roads at Port Lincoln, SA, on Saturday 11<sup>th</sup> April and Sunday 12<sup>th</sup> April 2020.
  - Membership to the EP Autosports Club is also available, contact the Event Secretary for details.
  - The event is open to all vehicles that comply with Schedules A and B of the current CAMS Manual of Motor Sport. Category 1 vehicles are not permitted to compete, but may be used for demonstration purposes, and would be by Invitational only.
- 1.1.4 The CAMS Permit Number authorising the event is **520/1204/01**
- 1.1.5 The course to be used is proximately 1500 metres in length used on both days. Times will be accumulated over the 2 days.
- 1.1.6 Crews involved in accidents resulting in property damage are advised that they may be required to pay up to the first **\$1000** of any claim to rectify such property damage. Certain public, property, professional indemnity and personal accident insurance is provided by CAMS in relation to the event. Further details can be found in the **CAMS Insurance Handbook**, available at [www.cams.com.au](http://www.cams.com.au).

### Article 1.2 Sponsor/Official Rides:

#### **During Breaks between competitive activities EVENT SPONSOR and EVENT OFFICIAL Appreciation rides may take place.**

- 1.2.1 Participation in these activities will be by **invitation only** from the Event Organisers.
- 1.2.2 All relevant Documentation relating to Passenger in Vehicle Experiences is to be completed by **ALL** Drivers and **ALL** Passengers prior to the activity commencing. This event will include a Motor Sport Passenger Ride Activity (MSPRA) which shall be run under and in accordance with the CAMS MSPRA Policy
- 1.2.3 Minimum Licence requirement for the Driver is Level 2 Speed and current civil drivers licence.
- 1.2.4 Drivers are to be briefed separately to the Event Drivers Briefing and prior to the Activity commencing
- 1.2.5 Passengers are to be briefed immediately before the activity commences.
- 1.2.6 Deleted
- 1.2.7 Vehicles must complete Scrutiny prior to the activity commencing.
- 1.2.8 Clothing and Apparel requirements for this activity is as per Article 6.1.2 of these Supplementary Regulations

## 5 JUDGES OF FACT

### Article 5.1 – JUDGES OF FACT

In accordance with NCR 181 the following officials are deemed to be Judges of Fact ➤

Officials of the event are deemed to be Judges of Fact of the following

- Not wearing seat belt, helmet or safety clothing
  - Service Park infringements
  - Shortcutting the course
- Scrutineers are deemed to be Judges of Fact of the following:
- Vehicle in un-roadworthy condition
  - Oil leaking from vehicles
  - Vehicle with accident damage
  - Eligibility of Vehicles
  - Driver Apparel
  - Dorian placement
- Medical Officers are deemed to be Judges of Fact of the Medical condition of
- Any crew member, team member or officials.
- Speed Monitoring Officials using suitable equipment are deemed to be Judges Fact to the Speed
- Of a competing vehicle or service vehicle.

## 6 COMPETITOR ELIGIBILITY

### Article 6.1 - COMPETITOR ELIGIBILITY

#### 6.1.1 Licences:

The driver shall hold, as a minimum, a current CAMS Level 2S, Level 2SJ Licence or equivalent 'Single Event' Licence (L2SE). Single event Licence application forms are available from the event organisers and can be completed prior to the events close of entries. Minimum age for competitors is 16.

#### 6.1.2 Clothing and Apparel:

6.1.2.1 Safety helmets, as to AS1698 standard (or otherwise to the standard listed in Schedule D of the current CAMS Manual of Motor Sport) are mandatory.

6.1.2.2 Clothing of a non-flammable material shall extend from neck to wrist and ankle. Shoes with a leather upper or of a better standard (e.g. racing shoes to FIA standard) must be worn.

6.1.2.3 All open Sports and Racing Car drivers must wear goggles or a visor to AS 1609/1981. Goggles with glass lenses, whether laminated or not are unacceptable.

6.1.2.4 Frontal Head Restraints, driving suits and gloves are recommended but are not mandatory. All apparel shall be in accordance with Schedule D of the current CAMS Manual of Motor Sport.

**The Organisers reserve the right to review and exclude any driver who has been identified in the past or during the event in any officially observed incidents that bring the sport into disrepute, either prior or during the event.**



## 7 VEHICLE ELIGIBILITY

### Article 7.1 - VEHICLE ELIGIBILITY

Entries will be accepted for the following classes:

#### Road Registered Vehicles

0-2000cc  
2000cc-4000cc  
4000cc and over  
4WD up to 3500cc  
4WD over 3500cc

Road Registered Vehicles can use semi slicks (legal for road use) but not racing slicks.  
Can use different turbo and intercooler.  
Can have half cage or hoops behind the driver's head

#### Race & Rally Cars (this class is for dedicated competition vehicles)

0-2000cc  
2000cc-4000cc  
4000cc and over  
4WD up to 3500cc  
4WD over 3500cc

In the case of insufficient entries in any class, i.e. fewer than 3, the class may be amalgamated with the next highest class in the same group (i.e. the class above).

All competing vehicles must comply with **SCHEDULE A** and **SCHEDULE B** of the current CAMS Manual of Motor Sport

All competing vehicles shall carry a properly affixed Fire Extinguisher complying with the provisions of Schedule H of the current CAMS Manual of Motor Sport. Vehicles must be adequately muffled to comply with noise restrictions.

## 8 DRUGS IN MOTORSPORT

### Article 8.1 - ALCOHOL, DRUGS AND OTHER SUBSTANCES

- 8.1.1 All Competitors and Pit Crew Members are reminded of the CAMS Anti-Doping policy in the Current CAMS Manual of Motor Sport (General Regulations).
- 8.1.2 Any holder of a CAMS 'Competition' or 'Officials' licence (or equivalent licence issued by another ASN) may be tested for the presence of drugs (or other banned substances) and subject to a penalty(ies) for a breach in accordance with the CAMS Anti-Doping Policy and/or the CAMS Illicit Drugs in Sport (Safety Testing) Policy as published on the CAMS website. Consumption of alcohol in the paddock, pits or any section of the competition venue/course under the control of the Officials is forbidden until all competition is concluded each day. Accordingly, any holder of a CAMS 'Competition' or 'Officials' licence (or equivalent licence issued by another ASN) may also be tested for the presence of alcohol by a CAMS Accredited Testing Official (CATO) in accordance with the CAMS Standard Operating Procedure for Breath Alcohol Testing.

## 9 RUNNING OF THE EVENT

### Article 9.1 - RUNNING OF THE EVENT

- 9.1.1 The driver **MUST** be present at **0900 hrs on 11th of April 2020** at the Yacht Club for Drivers Briefing, to sign on. Non-attendance will be a penalty of refusal to start.
- 9.1.2 The Opening Ceremonial will start at **1000 hrs on Saturday 11<sup>th</sup> April 2020** and the last car will finish on **Sunday 12th April 2020** at approximately **1700 hrs**.
- (a) The event will comprise of a minimum of 3 runs over the Saturday course and a minimum of 4 runs over the Sunday Course.
  - (b) Each driver will be offered the opportunity to drive through each course on the relevant day prior to any competition, during an untimed and speed-limited reconnaissance activity.
  - (c) For the purpose of establishing order of merit, the time recorded by a driver for all runs, for which the entire field (less any retirements) has the opportunity to participate in, will be aggregated. The driver recording the lowest aggregate time will be declared the winner.
  - (d) Any competitor that fails to start a run (DNS) or finish (DNF) a run will be given a derived time of 2 minutes as their result for the incomplete run.
  - (e) On the reconnaissance activity, helmets do not need to be worn, but other normal minimum speed event apparel must be worn (e.g. no shorts or tee shirt etc.).
- 9.1.3 Cars may start only at the discretion of the Starter and Clerk of Course.
- 9.1.4 Re-runs will only be permitted under the following circumstances:
- (i) failure of timing equipment.
  - (ii) if a Red Flag is used to stop a run and the drivers have not completed the run, or if you are slowed by the car in front. If you are the cause of a red flag then you will not be offered a re-run.  
All times recorded in the re run are to count towards the results.
  - (iii) Re-runs will be at the discretion of the Clerk of the Course.

## 10 CHANGES CREATED BY CIVIL AUTHORITIES

### Article 10.1 - CHANGES CREATED BY CIVIL AUTHORITIES

- 10.1.1 These Regulations are issued subject to any provisions made mandatory for the conduct of the event by the relevant civil authorities between the date of issue of these Regulations and the conduct of the event.

#### 11.1.2 The entry fee for the Event is fixed as follows:

- Competitors have **30 days** after receiving confirmation of acceptance of entry to make full payment before their place is offered to the next available competitor. Acceptance of entry will still be made by the Teakle Auto Sprint Pt Lincoln Committee.
- All entry fees must be paid by close of entries on **Friday 28<sup>th</sup> February 2020**

**Entry Fee is \$575 inc GST, with a deposit of \$150 to be paid on entering. The remaining \$425 is to be paid upon the acceptance by the organising committee of your entry.**

**Any entries that are not accepted will have their deposit refunded.**

**All Withdrawal's must be in writing to event Secretary**

**Withdrawal after the close of Final entries will forfeit entry fee paid.**

**Withdrawals before close of entries will receive 75% of their entry fee returned.**

11.1.3 The organisers reserve the right to cancel or postpone the event in accordance with NCR 59 of the current CAMS Manual of Motor Sport, should the number of entries be less than 50 or due to circumstances which result in force majeure. Maximum limit of entries is 75 which includes 5 wildcards by the organising committee. If the maximum number of entries is received, then a reserve list will be formulated. 2 entries are reserved for the organising committee.

## 12 PITS AND RE-FUELLING

### Article 12.1 - PIT AREA AND RE-FUELING

- 12.1.1 There will be no refuelling in the lawned pit area. Cars may be re-fuelled on the Northern end of Tasman Terrace when the team supplies its own fire extinguisher and official.
- 12.1.2 The speed of cars in the service park must not exceed 10km/h; offenders will be reported to the Stewards of the Event, who will decide on a penalty.
- 12.1.3 Fuel shall be in accordance with Schedule G of the current CAMS Manual of Motor Sport.

## 13 DOCUMENTATION AND SCRUTINY

### Article 13.1 - DOCUMENTATION AND SCRUTINY

- 13.1.1 Documentation will be available during the following times and must be completed prior to presentation of that vehicle for scrutiny – 1200 hrs to 1700hrs on Friday 10<sup>th</sup> April 2020 or Saturday 11<sup>th</sup> April 0700hrs to 0900hrs at Eyre Street Foreshore (Yacht Club)
- 13.1.2 Vehicles must be presented for scrutiny either 1200 hrs to 1700hrs on Friday 10<sup>th</sup> April 2020 or Saturday 11<sup>th</sup> April 2020 0700hrs to 0900hrs in the Pits (Eastern end). Vehicles are required to be presented to the scrutineers in a clean state with no oil leaks.
- 13.1.3 Documents to be presented at documentation include:
- CAMS Competition Licence
  - CAMS Automobile Log Book (if the vehicle has one)
  - CAMS Affiliated Club Membership Cards
  - Registration/Permit papers for road registered cars.
  - Civil Drivers Licence.

All documents presented must be current & not expire over the duration of the event.

- 13.1.4 The Driver **MUST** be present at documentation.
- 13.1.5 Any competitor who fails to meet vehicle re-presentation requirements as directed will be refused permission to start the event. Entries may be refused in accordance with NCR 83 of the current CAMS Manual of Motor Sport.

## 14 PROTESTS

### Article 14.1 - PROTESTS

- 14.1.1 Protests, if any, must be lodged in accordance with Part XII of the NCR. Protests relating to the eligibility of an automobile shall be made within 30 minutes of the completion of the competition activities.

## 15 RESULTS

### Article 15.1 - RESULTS

15.1.1 Where a driver has stopped or has been slowed during a heat to render assistance to another crew after an accident or slowed due to a car on the racing line, then that crew will be given a re-run at the most convenient time at the Clerk of Courses discretion.

Results will be based on accumulated times

### Article 16.1 - AWARDS

16.1.1 The Trophy Presentation will be held on Sunday 12th April 2020 at the Yacht Club on Tasman Terrace at 1830hrs. 2 Presentation Dinner tickets will be supplied with the entry fee.
